AKTA CUKAI PELANCONGAN 2017

PERATURAN-PERATURAN CUKAI PELANCONGAN (PINDAAN) 2026

PADA menjalankan kuasa yang diberikan oleh seksyen 70 Akta Cukai Pelancongan 2017 [Akta 791], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Cukai Pelancongan (Pindaan) 2026**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2026.

Pindaan peraturan 19

2. Peraturan-Peraturan Cukai Pelancongan 2017 [P.U. (A) 228/2017] dipinda dalam subperaturan 19(1)—

(a) dalam perenggan (a), dengan menggantikan perkataan “di Negeri Melaka” dengan perkataan “di Negeri Johor, Melaka”; dan

(b) dalam perenggan (b), dengan memotong perkataan “Johor,”.

TOURISM TAX ACT 2017

TOURISM TAX (AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by section 70 of the Tourism Tax Act 2017 [Act 791], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Tourism Tax (Amendment) Regulations 2026**.

(2) These Regulations come into operation on 1 September 2026.

Amendment of regulation 19

2. The Tourism Tax Regulations 2017 [P.U. (A) 228/2017] are amended in subregulation 19(1)—

(a) in paragraph (a), by substituting for the words “in the States of Malacca” the words “in the States of Johore, Malacca”; and

(b) in paragraph (b), by deleting the words “Johore,”.
